**Categories**

1. **Alpaca(s) Interacting:** at least one (1) alpaca interacting with other animals (including other alpacas), humans or inanimate objects.
2. **Black and White:** must include at least one (1) alpaca and have artistic merit.
3. **Computer Enhanced:** Use your computer skills and imagination to enhance that favorite alpaca photo with a computer graphics program. [Computer enhanced photos **DO NOT** include photos taken with warming, cooling, polarizing, diffusing, softening or neutral density filters.]
4. **Cria:** A pre-weanling alpaca caught in that special moment.
5. **Farm Scene:** Your picturesque farm photo that includes at least one (1) alpaca.
6. **Humor:** Those alpaca photos that just make you laugh.
7. **Youth:** Any alpaca photo taken by a young person, age 16 or below.

**Competition Rules**

- A. All photos must include at least one (1) alpaca.
- B. Submitted photos must be a 5" x 7" only. Submitted photos must be printed with a glossy or matte finish only. No foam board matted photo's allowed.
- C. Photos entered in the competition have no time limit. However, photos published in any advertising materials or median, on websites, or winning photos of the AOA Nationals and/or photos used in Alpaca Culture Magazine are not eligible.
- D. Permission to publish these photos is granted by virtue of entering this contest. All rights are released to Carolina Alpaca Breeders and Owners.
- E. Up to two (2) photos per person per category (except Youth) are allowed.
- F. Up to three (3) photos per person for the Youth category are allowed.
- G. Winning photos will receive 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> place ribbons in each category; a Judge's Choice ribbon will be awarded and a Best in Show (chosen by the public) purple ribbon will be awarded.
- H. All are welcome to enter photos in the contest.
- I. **ALL entries must be postmarked by February 1, 2020.**
- J. All photos will be judged for content, composition, creativity and how well they depict the category.
- K. Winning entries become the property of CABO and will be published on CABO's website. All other entries may be picked up after 2:00PM Sunday February 16, 2020.
- L. **NO PHOTO CONTEST ENTRIES WILL BE ACCEPTED AT THE SHOW.**
